### **Bridges**

**Goal:** Monitor VTRANS covered bridge wing wall repair grant during the bid solicitation, contracting and repair process and insure that progress stays on schedule.

**Actions**: SB will monitor VTRANS grant requirements and timeline.

Goal: Continue to pursue funding for Waterman Rd. and the other bridge and culvert projects prioritized on the Structures Capitol Plan prepared by the Road Foreman.

### **Regional Library Building**

**Goal:** Complete the transfer of the facility on Putney Road from the State to the Southeastern VT Learning Collaborative.

**Actions:** Work with Casey Murrow at Southeastern VT Community Learning Collaborative to ensure a smooth transfer with a net zero cost to the Town.

#### **Town Gravel Needs**

**Goal:** Execute contract with Renaud Gravel, Inc and the Town of Putney to access the gravel deposits behind Hidden Acres on Putney Road

#### Plans:

- A. Notify and discuss with neighbors any concerns they might have for the project.
- B. Take necessary steps to satisfactorily complete the Act 250 permitting process
- C. Plan for the eventual transition from the Carpenter Pit.

# **Dutton Pines State Park**

**Goal:** Stay connected with the Dept. of Forest, Parks and Recreation to explore the potential future uses and condition of the park.

#### **Ancient Roads**

**Goal:** Locate and consolidate existing materials from efforts over last few years and examine vault records to determine history, status, etc. in preparation for the July 2015 ACT 178 Deadline to identify all town rights of way.

Plans:

- A. Budget funds to commission a document search of Town records.
- B. Contact *Old Maps* in W.Chesterfield, NH 413-772-2801 for any pertinent maps.

### **Windham Solid Waste Management District**

**Goal**: Monitor WSWMD budget and waste management issues to insure town is actively involved in and aware of waste management issues and WSWMD decisions.

**Plan:** efforts with other WSWMD towns when necessary; communicate more frequently and thoroughly with WSWMD representatives.

**Goal:** Monitor RERP revisions and disaster drills to make plan as practical as possible.

### **Town Plan and Zoning Bylaws**

Goal: Revise Zoning Bylaws to conform to new Town Plan.

**Plan:** Work with Planning Commission and other Town committees to insure a smooth and open public process.

#### **Action:**

- **A.** Take recommendation of the Routes 5/30 Corridor Committee and the Planning Commission to amend the Town Plan as directed in the Plan.
- **B.** Work with Planning Comm. and Zoning Administrator to prioritize the schedule of hearings on Zoning Bylaw revisions.

Primary Oversight: Selectboard

**Goal:** Redefine the focus of the Farmland Protection Fund.

#### Plan:

- A. Meet with the Farmland Protection Committee to discuss feasibility/necessity of including open land in Dummerston under purview of Farmland Protection fund.
  - B. Solicit information and recommendations from FPC during Zoning Bylaw rewrite process.
  - C. Explore with FPC additional funding options and partnerships with other organizations, land trusts, etc.

### **Employee Health Plan**

**Goal:** Review with Town employees the suitability of the new town health insurance policies and Health Savings Accounts.

### **West Dummerston Community Center**

**Goal:** Promote the Community Center to its highest and best use.

**Action:** Continue to work with the Community Ctr trustees to develop a capital plan for the building and a plan to generate revenue for its upkeep.
