SELECTBOARD MEETING MINUTES

This meeting was called to order by Zeke Goodband at 6:00pm at the Town Offices in Dummerston, Vermont.

On a motion by Lewis and second by Joe, the Board voted 4-0 to approve the meeting minutes of March 19th.

On a motion by Lewis and second by Joe, the Board voted 4-0 to approve the payment of Warrants 20, 20P, Energy Committee #9 and Conservation Commission #6.

The Board recognized Planning Commission Chair, Sam Farwell, who went over the proposed changes to the Zoning Bylaw. Public forums are scheduled for April 22 at 7pm at the Community Center, and May 6 at 7pm in the basement of the Congregational Church. A public hearing is scheduled for June 24 at 7pm (site TBA).

The Board reviewed a town highway bridge pre-candidate list from the Windham Regional Commission; a VT Local Roads update; a model Drug & Alcohol Policy for commercial vehicle operators from VLCT PACIF. They also reviewed a request from a resident of Sugar Maple Drive for "school bus stop ahead" signage on Houghton Brook Road. The Road Crew will clear the brush obstructing the signs currently in place.

Lewis moved to approve the bid specifications for the new one-ton truck. Joe seconded the motion; it passed 4-0.

On a motion from Lewis and second by Joe, the Board voted 4-0 to approve a request from School Nurse, Mary Ann Runge for an allocation from the Miller Fund, not to exceed \$365.

At Laurie's request, the Board revisited her performance evaluation as Selectboard Assistant. Joe will make some revisions and bring it back to the Board at the next meeting.

Gurudharm will invite Rick Davis and Larry Lynch to come to the next meeting to talk about Emergency Management.
