#### **Road Foreman's Report:**

FEMA Update: Lee, Terry and Charlotte met with Bill Doyle. There is no update for Schoolhouse Road. Camp Arden Road will require an engineering study and then start the bidding process.

Total road repairs done is \$195,202.68, the Towns portion will be \$24,434.00. All category A & B repairs have been submitted to FEMA. Most likely will not see reimbursement until sometime after July 1<sup>st</sup>.

Johnson's Curve Road repairs will most likely need to wait until spring.

Lee is working on work easements from landowners on Camp Arden Road and will contact the engineer to get that started.

It was the consensus of the Board and Lee, that he will focus on Camp Arden Road and push the Leonard Road project into next year.

Lee met with Faith's Ford in Westminster regarding the trade value for the Dodge dump truck. He was hoping to get a higher trade in value. He will have numbers for the next meeting.

Lee used Nystrom Service & Repair in Townshend for equipment repair work. Tyler was able to work with them at their shop. Nystrom works on all types of equipment.

The Road Crew is all set for the weekends predicted storm.
