The Board briefly discussed Conservation Commission's Wildflower Pocket Garden proposal for Route 5 at pull off north of Canoe Brook Road. VTrans will do the planting and town volunteers will mow/cut it off in the Fall.

On a motion by Todd and second from Alex the Board voted 5-0 to send letter of support for the proposal for a wildflower pocket garden to VTrans. Todd will sign it and have Laurie send it to the State.

(added to agenda):

Community Center & Library invoice payments: Terry stated that there is a meeting set up next Tuesday 5/5 with the Trustees, DCC Board, Town Treasurer, and at least Terry from the Selectboard. Terry will invite Lester Dunklee to the meeting and Todd will invite Randy Hickin. A few questions have come up: Library expense vs Community Center building expense? Will money in the DCC fund pay bills until the lease is terminated and will remaining funds transition

to the new entity? Chris stated that there are outstanding checks to the DCC that have not been deposited. The lease termination will be added to the next meeting agenda.

Paul is waiting on a walk through to see if a water softener can go in the Town Office that could serve the Office and the Fire Department.

He is still waiting on a new well pump price.
